- Places fewer demands on contracting organizations

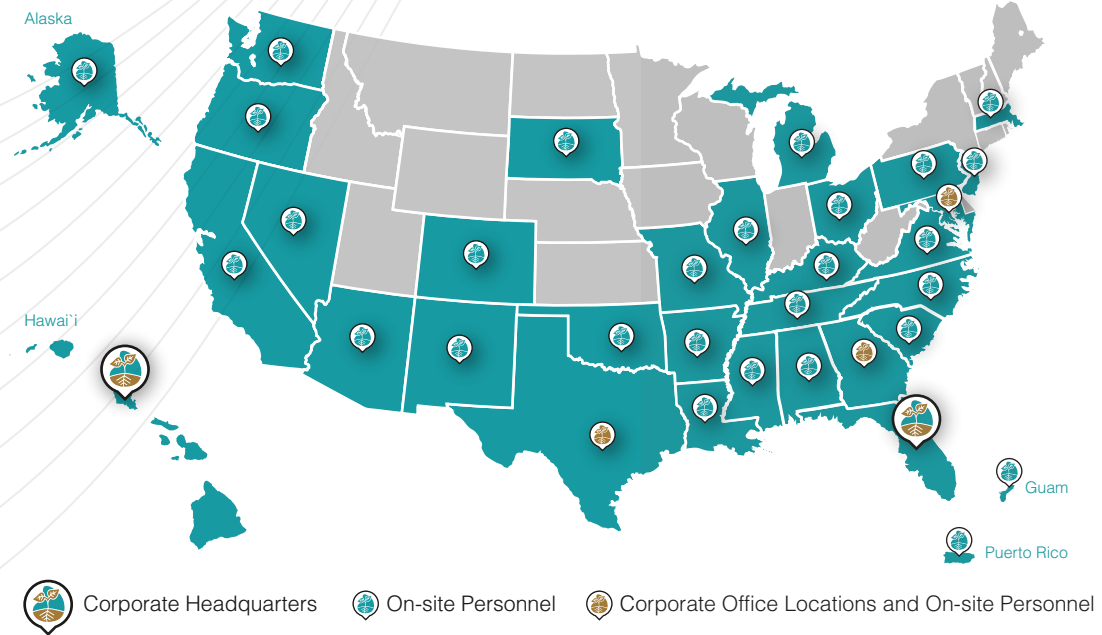
